Makers and endorsers hereof jointly and severally waive presentment for payment, notice of nonpayment, the right of protest and further agree to any extension of time of payment and partial payments before, at or after maturity. Makers further agree that if suit is brought hereunder, or foreclosure initiated, to pay all costs of collection, including reasonable attorney's fees, expenses, court costs and all fees and costs of the Public Trustee.

MAKERS SWEAR, AFFIRM AND REPRESENT that he/she/they are the owner of the real property described above, free and clear of liens or encumbrances, subject only to the exceptions duly noted above.
